#### IV. SELECTION PROCESS

1	Selection to these posts will be made on basis of the recommendation of Selection Committee and				
1.	subsequently approved by BOG of the Institute.				
2.	Institute will conduct written test for each post separately to screen/ prioritise the applicants to be called for documents verification/ interview.				
3.	The submitted applications will be scrutinized by the Institute and only the candidates fulfilling requirements as per advertisement will be invited for the written test. It is in the interest of applicants that they should satisfy themselves regarding the eligibility requirements before apply for any of the posts. During documents verification if the applicant fails to prove his/her eligibil then his/her candidature will be removed from the list and his/her fee deposited will be forfeited no refund of any kind will be permitted.				
4.	All the eligible applicants after scrutiny will be required to appear for written test to be conducted fo each post. The minimum qualifying score in the written test is 50% to become eligible to be included in the merit list to be prepared for documents verification and interview.				
5.	The syllabus for written test will be uploaded on the institute website.				
6.	Only 15 candidates for each post in each category, based on the merit in the written test, will be calle for documents verification and interview. In case, the number of candidates, who qualify the written test is less than 15, only candidates who qualify the written test will be called for document verification/interview in that particular category.				
7.	The candidates called for documents verification will be required to present all the original certificates before the document verification committee.				
8.	The applicants who fail to produce the original documents will not be allowed to appear in the interview.				
9.	Interim enquiries about the result will not be entertained.				
10.	No correspondence will be entertained from the applicant either before or after the selection. The decision of the institute would be final.				
11.	No request for change in date for written test/documents verification/interview would be entertained.				

# **V. SELECTION CRITERIA:**

Final merit will be prepared based on the following criteria:-

 A written test (Multiple Choice Questions based) will be conducted to screen the applicants to be called for documents verification and interview. A candidate must obtain minimum



- 50% marks in the written test to be eligible for being called for documents verification/interview.
- 2. Only 15 candidates will be called for interview for each post in each category, based on the merit list prepared on the basis of written test. However, if the applicants who qualify the test are less than 15, the candidates to be called for interview will be limited to only those who qualify the written test in that category. Written test will be qualifying in nature and the marks obtained in the written test will not be counted towards final selection purposes.
- 3. Shortlisted candidates, based on the written test, will be called for documents verification and interview. The final selection will be on the basis of the following criteria:
